Expenses \$2.00

There shall be one scholarship prize for every 4 entries.  
All scholarship money won will be deposited into the SMARTS  
account for the bowler.

PRIZE FUND will be returned 100%

### FORMAT:

Scratch Division: The top 8 bowlers  
by total pin-fall will advance to the  
Finals.

Handicap Division B and C: The top  
8 bowlers by total pin-fall will  
advance to the Finals.

If a tie exists for the last qualifying  
position, a 10th frame roll off will  
be held right after qualifying.

Limited to 72 entries. Qualifying  
round shall consist of five (5) games  
across 10 lanes. Finals will be  
Single-Elimination format, with one  
game match play.

**Dress code will be enforced.**

## Junior Tournament Rules

1. Competitors will receive handicap each game during Qualifying and Finals, if in division B and C.
2. Handicap will be 90% of 200 average.
3. 2017/2018 Book Average of 12 games or more will be used, submit verified proof of average from League Secretary. If there is no 2017/2018 Book Average then your 2016/2017 Book Average of 12 games or more will be used. If no average then an average of 200 will be used and bowl scratch.
4. The Tournament Committee shall determine starting lanes for Match #1. Lane assignments will be posted before the start of the finals. Practice on Saturday at 2:50 pm. Winners will continue to bowl in the Tournament.
5. Alternates: **None**. If the qualifying bowler does not show up for the finals, he/she shall receive zero for the frames missed. See rule #6.
6. **SLOW PLAY**: If tournament officials conclude that you are slow playing you will be warned once, and on the 2nd time given 0 pins for the frame.
7. **DRESS CODE**: This rule for **QUALIFYING & FINAL** rounds. **All bowlers must wear proper attire (NO TANK TOPS/ T-SHIRTS/ATHLETIC SHORTS). Skirts, Shorts, and Jeans** may be worn in competition. Competitor's hemline can only be 3" above the knee. Any shorter the skirt and/or short is considered too short and not suitable. Collared Shirts are recommended. Mock turtle necks will be permitted. Earrings are permitted as long as they are in good taste. **Items Protruding From Clothing**: Items that hang or protrude from apparel may **NOT** be worn during competition. **Headwear, hats, scarves, bandanas or non-elastic sweatbands may NOT be worn during competition. NO USE OF ELECTRONIC DEVICES BY ENTRANTS ONCE TOURNAMENT HAS BEGUN, THIS INCLUDES ALL EARBUDS, HEADPHONES, OR ANY EAR DEVICE.**
8. **CONDUCT**: If any of the following are violated it will lead to immediate disqualification: **1. Deliberate foul, 2. Smoking or using Tobacco products during tournament play, 3. Obscene gestures or Profanity, and 4. Kicking of lane equipment.**
9. **TARDY BOWLERS**: Any bowler who qualifies for the finals and does not show up by 3:00 pm shall receive zeros for every frames missed. They can still complete the game for frames not yet missed. If they miss the two games they will be eliminated from the Tournament.
10. USBC rules shall prevail in case of any omissions. USBC Sanctioned.
11. All decisions of the Tournament Committee shall be final. Any appeals must be made in writing in accordance with USBC Rule 329.
12. Premature termination of the tournament brought about by war, national emergency causes relating thereto or there from fire, natural disaster or any other reason beyond the control of the Modesto USBC Association Junior Tournament shall cause, to the extent required, thereby, all advertised prizes, guaranteed or otherwise, to be prorated in accordance with the number of entrants who have bowled in the event up to the time of such termination.

### For consideration to participate in the Junior Tournament, I agree to the following:

1. To abide by all Tournament rules and regulations of the United States Bowling Congress and all special rules and regulations governing the Tournament.
2. **SEE RULE #7** for Dress Code Requirements.
3. After my entry has been accepted, I cannot transfer the entry except with the written consent of the Tournament Committee. In no case is the Tournament Committee of Modesto USBC Association obliged to return my entry fee. Request for transfers shall be made no less than one hour before assigned squad time.
4. The only sum(s) of money in which I will be entitled to as a result of participation in this Tournament are those prizes or awards listed in the prize fund.
5. Entry Fee: Only Checks, Money Orders, Cashier Checks, Cash will be accepted. Personal Checks accepted until 06/09/2018.
